

Cookies Policy - - Last updated: 29th January 2019

TCR Group (as defined below*) ("TCR" or "our") uses cookies on the <https://www.tcr-group.com> website (the "Website").

What is a cookie and why does TCR use these?

A cookie is a small text file that the Website saves on your computer or mobile device while you are accessing the Website. A cookie file is stored in your web browser and allows to recognize you and make your next visit easier and more useful to you. It enables the Website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.

This allows us as well to make the Website more user-friendly.

Cookies can be "persistent" or "session" cookies. Persistent cookies remain on your personal computer or mobile device when you go offline, while session cookies are deleted as soon as you close your web browser.

When you use and access the Website, TCR may place and use a number of cookies files in your web browser with the following purposes:

- To enable certain functions of the Website (technically necessary cookies)
- To provide analytics
- To store your preferences

TCR uses both session and persistent cookies and uses different types of cookies to run the Website:

- Strictly necessary cookies, required for the operation of the Website. TCR may use these cookies to authenticate users and prevent fraudulent use of user accounts.
- Preferences cookies. TCR may use preferences cookies to remember information that changes the way the Website behaves or looks, such as the "remember me" functionality of a registered user or a user's language preference.
- Analytics cookies. TCR may use analytics cookies to track information how the Website is used so that we can make improvements. TCR may also use analytics cookies to test new advertisements, pages, features or new functionality of the Website to see how our users react to them.

Legal grounds for data processing via cookies

TCR processes personal data via the use cookies on the basis of you consent (ex. cookies used for analytics) or legitimate interests (ex. use of technically necessary cookies).

Third-party cookies

In addition to our own cookies, TCR may also use various third-parties cookies to report usage statistics of the Website, deliver advertisements on and through the Website, and so on.

Disabling cookies or setting preferences for cookies

When the Website is accessed, the Website User is informed on the use of cookies. You can delete, refuse or restrict cookies by instructing or changing the setting in your internet browser.
